

PURCHASE ORDER INTENTION

THE UNDERSIGNED (“PURCHASER”) hereby orders to Seiko Watch Corporation, a Japanese corporation with its principal place of business at 2-1, Shibaura 1-Chome, Minato-ku, Tokyo 105-8467 Japan (“SELLER”) certain product identified in Clause 1 below on the following terms and conditions.

Clause 1: Product and Price

One (1) piece of CREDOR Spring Drive Sonnerie (Ref No.GBLQ998) (“PRODUCT”) for the price of JPY 15,000,000 (Fifteen Million Japanese Yen). The price includes the cost of transportation and insurance from Seiko’s warehouse in Japan to the port of entry of your domicile (CIF port of entry). However, the price does not include other cost such as import duty, sales tax, value-added tax and fee for import agency.

Clause 2: Conditions

In ordering PRODUCT, PURCHASER hereby agrees as follows.

- 2.1 Purchase of PRODUCT is for PURCHASER himself/herself and is not for, or on behalf of, any other person or entity.
- 2.2 The Purchase Order is not accepted by SELLER until a SALE AND PURCHASE AGREEMENT is executed between SELLER and PURCHASER, with a payment of deposit by PURCHASER to SELLER, pursuant to Clause 3 below.

Clause 3: Sale and Purchase Agreement

In the event that SELLER decides to offer PRODUCT to PURCHASER (which decision is to be made at the sole and absolute discretion of SELLER), SELLER shall forward to PURCHASER a sale and purchase agreement (“SALE AND PURCHASE AGREEMENT”) together with an invoice for a deposit (in the amount of JPY5,000,000) to be paid by PURCHASER to SELLER within three weeks from the date SELLER and PURCHASE have signed the SALE AND PURCHASE AGREEMENT.

NO AGREEMENT BETWEEN SELLER AND PURCHASER SHALL BE REACHED UNTIL AND UNLESS PURCHASER REVIEWS AND EXECUTES THE SALE AND PURCHASE AGREEMENT AND RETURN POLICY, AND SUBMITS A DEPOSIT TO SELLER PURSUANT TO THE TERMS OF THE SALE AND PURCHASE AGREEMENT.
